Recently, the Liberal government has proposed significant new fees on the import, manufacture, and sale of natural health products while simultaneously imposing new labelling laws that will massively increase the cost of all these products.

These regulations are being applied to many products Canadians use every day like protein powder, vitamins, and other supplements.

These recently announced rules are set to come into effect on June 21, 2025. Once the rules come into place, 70% of brands say they will have to pull products from the market and 1 in 5 brands are considering leaving Canada altogether. At a bare minimum, the costs of these products will rise dramatically.


The existing rules on natural health products already keep Canadians safe.

Canadians should have control over their own nutrition and what they put into their bodies. The government should be making it easier for Canadians to look after their own health and make their own health choices, not harder.

Thank you to the thousands of Canadians who have written to myself and other MP's who want to protect their natural health supplements.

Conservatives are listening and we will fight these regulations in Parliament and work to protect access to natural health products.
